

Stock Donations

Thank you for considering making a donation of stock to OCPM. We are able to accept donations of stock through our patterner, Stock Donator, in one of two ways easy ways:

- 1. **From StockDonator's Online portal:** By going to <u>https://stockdonator.com/stock-information/?oid=ccf472ff</u> and follow the instructions to fill out the form.
- **2. Using the non-automated form below:** Fill out the paper form and email or fax it to StockDonator who will process the donation on our behalf.

NOTE: The paper form has 2 options. The first option on this form requires you to initiate the stock transfer with your brokerage. The benefit of option 1 is that is that it allows you to simply notify StockDonator of the transfer without giving any personal account information. The second option on this form has Stock Donator taking care of initiating the transfer with the organization, but that option will require you to provide information about their account to start the process.

Please note that if the paper form is used it is **VERY IMPORTANT** that a copy of the form is sent to communications@stockdonator.com so that they know how to process the stock donation.
